In 1989, the Sisters of Charity of Our Lady of Mercy created an organization “to provide educational, health and direct outreach services to people in need on James, Johns and Wadmaw Islands while encouraging and supporting self-sufficiency and self-esteem.”

Known by many simply as “the Outreach,” the agency provides emergency assistance, education and wellness services to the economically poor of Johns, James, and Wadmalaw Islands, and the Neighborhood House in Charleston. Assisted by the services of over 250 volunteers, and supported by donations from the community, The Outreach serves over 11,000 people per year.



The Sisters' Circle

In 1989, the Sisters of Charity of Our Lady of Mercy established Our Lady of Mercy Outreach with a significant gift. That endowment has grown over the years, but not enough to defray all of the costs associated with the many services the organization now provides. Today, the Outreach is challenged as never before.

Your planned gift can support the Outreach for many years to come, and it may provide benefits to both you

and your heirs. Some of the most popular options are described in this brochure. Please consider the information contained in this brochure a starting point, and consult with your attorney and tax advisor before making any planned gifts.



There are many ways to provide a planned gift. We have summarized some of the most popular.

Wills and Bequests

A bequest, or other testamentary gift, is one of the simplest and most popular ways to benefit a charity. Bequests are usually deductible for estate tax purposes. Through a bequest, a donor can give the Outreach a specific amount of money, a specific property, or a percentage of assets.

Life Insurance

Our Lady of Mercy Community Outreach Services, Inc. may be named as a beneficiary of a life insurance policy. Or, a paid-up life insurance policy may be given to the Outreach with the Outreach named as the beneficiary.

Gifts of life insurance may provide donors with significant tax savings while giving important assistance to the Outreach.

Working with your attorney, accountant or other tax advisor, the Outreach can assist you in determining if a gift of this sort is appropriate for you and your goals.



Gifts of Tangible Property

A gift of a residence, real estate, precious object or collection is a very personal and significant way to benefit the Outreach. In addition to providing donors with a deduction, such gifts may also eliminate liability for long-term capital gains taxes. Some elect to donate a home while retaining the right to live in it for the rest of their lives.



Charitable Lead Trusts

This is a way to provide a current or future gift to the Outreach, and eventually pass along assets to heirs. Such a gift may provide substantial tax benefits.



Charitable Gift Annuities

These are gift plans that provide the donor, or someone named by the donor, with a fixed income for life. The donor may also take a charitable deduction for a portion of the gift in the year in which the gift was made.
